Key Responsibilities:

The key responsibility of the Casual Animal Carer will be to have good knowledge in caring for a range of animals, provide excellent animal husbandry standards to all of the Colleges animal stock. They will have exceptional communication and demonstration skills to provide expert interactive sessions to the general public at weekends and during events and support the Animal Keepers with volunteering and work experience students. They will also be expected to maintain all records.

Responsibilities:

- 1. Be responsible for the day-to-day routine care of the College's animal stock, maintaining high standards of husbandry
- 2. Duties include cleaning of accommodation, provision of feed, water, bedding, nesting material, and daily health checks
- 3. The exercising, training and handling of animal stock as appropriate and as required
- 4. Ensuring that all requirements and regulations relating to health and safety are adhered to at all times
- 5. Completing records relating to routine animal care, reporting any abnormalities or problems to Line Manager as appropriate
- 6. Ensuring high standards of hygiene and cleanliness in all animal areas and associated storage and service areas
- 7. Assisting academic staff within the School, supervising students and providing technical assistance and advice as required
- 8. To provide assistance supervising volunteers and work experience
- 9. To support running the animal interactive education sessions with schools and groups during the week time
- 10. To be confident in public engagement activities and answering queries from members of public
- 11. Assisting with the coordinating and supervising animal interactive sessions for the public at weekends
- 12. Work with the marketing and events team to provide a great public experience
- 13. Any other reasonable duties of a comparable nature as required by the Line Manager

General Responsibilities:

- 1. Promote and implement all College policies, particularly those which refer to health & safety, equality of opportunity and Safeguarding young people and vulnerable adults
- 2. Participate in College programmes of staff appraisal and continuing professional development
- 3. Develop effective working relationships internally and with external partners
